Thank you for choosing to submit your paper to us. These instructions will ensure we have everything required so your paper can move through peer review, production and publication smoothly. Please take the time to read and follow them as closely as possible, as doing so will ensure your paper matches the journal's requirements. ### **ScholarOne Manuscript**

This journal uses ScholarOne Manuscripts (previously Manuscript Central) to peer review manuscript submissions. Please read the guide for ScholarOne authors (<http://authorservices.taylorandfrancis.com/category/making-your-submission/>) before making a submission. Complete guidelines for preparing and submitting your manuscript to this journal are provided below.

### **About the journal**

*Advanced Robotics* is an international, peer reviewed journal, publishing high-quality, original research. Please see the journal's Aims & Scope for information about its focus and peer-review policy (<http://www.tandfonline.com/action/journalInformation?show=aimsScope&journalCode=TADR20>).

Please note that this journal only publishes manuscripts in English.

This journal accepts the following article types: Full Papers; Survey Papers; Short Papers.

There are three categories of papers:

- Full Papers: Research reports with originality, including reports on experiments, development of theory, or technological application feasibility. They should not exceed 6000 words.
- Survey Papers: Systematically compiled survey in the particular field, not limited to achievements of the specific research. They should not exceed 6000 words.
- Short Papers: New technological ideas and approaches calling for quick announcement. They should not exceed 3500 words.

Word count above does not include table captions, figure captions, biographical note and acknowledgement.

Abstracts of up to 100 words for Short Papers or 200 words for Full/Survey Papers are required for all papers submitted.

Authors should select one or more research field(s) from the list in the submission site when paper is submitted.

After the paper is accepted authors are requested to supply a short biographical note for each author.

### **Peer review**

Taylor & Francis is committed to peer-review integrity and upholding the highest standards of review. Once your paper has been assessed for suitability by the editor, it will then be single blind peer-reviewed by independent, anonymous expert referees. ## **Preparing your paper**

### **Structure**

Abstracts of up to 100 words for Short Papers or 200 words for Full/Survey Papers are required for all papers submitted.

### **Word limits**

Please include a word count for your paper.

A typical Full Paper for this journal should be no more than 6000 words; this limit does not include tables; figure captions; biographical note.

A typical Survey Paper for this journal should be no more than 6000 words; this limit does not include tables; figure captions; biographical note.

A typical Short Paper for this journal should be no more than 3500 words; this limit does not include tables; figure captions; biographical note.

### **Style guidelines**

Please refer to these style guidelines ([http://authorservices.taylorandfrancis.com/tf\\_quick\\_guide/](http://authorservices.taylorandfrancis.com/tf_quick_guide/)). When preparing your paper, rather than any published articles or a sample copy

Please use any spelling consistently throughout your manuscript.

Please use single quotation marks, except where 'a quotation is "within" a quotation'. Please note that long quotations should be indented without quotation marks.

Long quotations of 50 words or more should be indented with quotation marks.

No changes – neither the addition nor the removal of a co-author – can be made to the list of co-authors after the article is accepted, unless submitted in writing by all authors including the person being added or removed, with the reasons for addition or removal, and thereafter agreed by the editor of the journal.

### **Formatting and templates**

Papers may be submitted in any standard format, including Word and LaTeX. All files, including LaTeX files, tables, figures and captions, should be embedded into the PDF prior to submission because ScholarOne Manuscripts is not able to convert files into PDFs directly. However, once a manuscript is accepted, figures, tables and captions should be saved separately from the text. To assist you in preparing your paper, we provide formatting templates.

A LaTeX template is available for this journal. Please save the template to your hard drive, ready for use.

### Checklist: what to include

1. **Author details.** Please include all authors' full names, affiliations, postal addresses, telephone numbers and email addresses on the cover page. Where available, please also include ORCiDs (<https://orcid.org/>) and social media handles (Facebook, Twitter or LinkedIn). One author will need to be identified as the corresponding author, with their email address normally displayed in the article PDF (depending on the journal) and the online article. Authors' affiliations are the affiliations where the research was conducted. If any of the named co-authors moves affiliation during the peer-review process, the new affiliation can be given as a footnote. Please note that no changes to affiliation can be made after your paper is accepted. Read more on authorship (<http://authorservices.taylorandfrancis.com/defining-authorship/>).
2. A non-structured **abstract** of no more than 200 words. Read tips on writing your abstract (<http://authorservices.taylorandfrancis.com/abstracts-and-titles/>).
3. **Graphical abstract.** This is an image to give readers a clear idea of the content of your article. It should be a maximum width of 525 pixels. If your image is narrower than 525 pixels, please place it on a white background 525 pixels wide to ensure the dimensions are maintained. Save the graphical abstract as a .jpg, .png, or .gif. Please do not embed it in the manuscript file but save it as a separate file, labelled GaphicalAbstract1.
4. You can opt to include a **video abstract** with your article. Find out how these can help your work reach a wider audience, and what to think about when filming (<http://authorservices.taylorandfrancis.com/video-abstracts/>).
5. Up to 5 **keywords.** Read making your article more discoverable (<http://authorservices.taylorandfrancis.com/making-your-article-and-you-more-discoverable/>), including information on choosing a title and search engine optimization.
6. **Funding details.** Please supply all details required by your funding and grant-awarding bodies as follows:  
*For single agency grants:* This work was supported by the[Funding Agency] under Grant [number xxxx].  
*For multiple agency grants:* This work was supported by the [funding Agency 1]; under Grant [number xxxx]; [Funding Agency 2] under Grant [number xxxx]; and [Funding Agency 3] under Grant [number xxxx].
7. **Disclosure statement.** This is to acknowledge any financial interest or benefit that has arisen from the direct applications of your research. Further guidance on what is a conflict of interest and how to disclose it (<http://authorservices.taylorandfrancis.com/what-is-a-conflict-of-interest/>).
8. **Biographical note.** Please supply a short biographical note for each author. This could be adapted from your departmental website or academic networking profile and should be relatively brief.
9. **Geolocation information.** Submitting a geolocation information section, as a separate paragraph before your acknowledgements, means we can index your paper's study area accurately in JournalMap's geographic literature database and make your article more discoverable to others (<http://authorservices.taylorandfrancis.com/making-your-article-and-you-more-discoverable/>).
10. **Supplemental online material.** Supplemental material can be a video, dataset, fileset, sound file or anything which supports (and is pertinent to) your paper. We publish supplemental material online via Figshare. Find out more about supplemental material and how to submit it with your article (<http://authorservices.taylorandfrancis.com/enhancing-your-article-with-supplemental-material/>).

11. **Figures.** Figures should be high quality (1200 dpi for line art, 600 dpi for grayscale and 300 dpi for colour, at the correct size). Figures should be saved as TIFF, PostScript or EPS files. More information on how to prepare artwork (<http://authorservices.taylorandfrancis.com/submission-of-electronic-artwork/>).

12. **Tables.** Tables should present new information rather than duplicating what is in the text. Readers should be able to interpret the table without reference to the text. Please supply editable files.

13. **Equations.** If you are submitting your manuscript as a Word document, please ensure that equations are editable. More information about mathematical symbols and equations (<http://authorservices.taylorandfrancis.com/mathematical-scripts/>).

14. **Units.** Please use SI units (non-italicized) (<http://www.bipm.org/en/measurement-units/>).

### Using third-party material in your paper

You must obtain the necessary permission to reuse third-party material in your article. ### Submitting your paper

This journal uses ScholarOne Manuscripts to manage the peer-review process. If you haven't submitted a paper to this journal before, you will need to create an account in the submission centre.
